VOLUNTEER COACHING PROGRAMME INFORMATION

1. What is the Volunteer Coaching Programme?

The Volunteer Coaching Programme is designed to provide on-site support to credit unions through the provision of demand-driven technical support. The volunteer coaches, working in teams of two, will provide on-the-ground technical assistance to their counterparts in Sierra Leone, and follow-up remotely on return home. When in-country the coaches will work closely with field office staff and visit targeted credit unions, liaising with credit union staff and Board members to identify any issues and put forward practical solutions to strengthen the credit union.

The Volunteer Coaching Programme has been running since 2009, and to-date over 20 managers/CEOs and senior staff have participated in the programme sharing their experience with our credit union partners in Ghana, Sierra Leone and The Gambia.

2. About the Foundation

The Foundation is the charitable arm of the Irish credit union movement, with a mission to alleviate poverty in developing countries by supporting credit unions (CU), their representative bodies and other co-operative type organisations as a means for socio-economic development through the provision of financial and technical assistance. Over the last thirty years the Foundation has worked to strengthen the role of credit unions and savings and credit cooperatives in developing countries by sharing the success of the Irish credit union movement and the experience of international partners. The specialist focus of the Foundation is long-term technical assistance, support and training, to improve the quality and efficiency of nascent credit union movements in programme countries.

The Foundation uses its experience and expertise to identify and provide contextually appropriate transfer of skills and expertise to partners, helping them to develop sustainable structures, procedures and practices to alleviate poverty. The Volunteer Coaching Programme is a means of providing technical support through directly sharing the Irish credit union experience.

3. What is the benefit of getting involved?

Volunteering with the Foundation is an opportunity to give back to the credit union movement. It allows you to directly support the development of credit unions, work closely with staff and Board members and see at first-hand the work that Irish credit unions are supporting through the Foundation. Previous coaches have reported personal satisfaction in imparting skills and training to other credit unions, and noted it was also a great learning experience.

4. Who is eligible to participate?

We are looking for volunteer coaches who are well rounded and experienced credit union staff, and ideally have experience of manual operating systems. The coach will be a credit union professional with experience of both credit union operations and governance, and managing people and relationships. Topics to be covered are driven by the needs of the Sierra Leonean credit union movement, and the current three-year Step-Up project. The CUs in Sierra Leone are focussed on improving their CU operations and governance, particularly as it relates to credit control, loan delinquency management, membership growth and risk management.

The overall goal for the volunteer programme for 2023 is to increase the capacity of the Sierra Leonean credit union movement in CU governance. Areas of focus for the volunteers include:

- review of the governance and-respective roles of the CU Board and management in a small number of pre-selected credit unions in Sierra Leone
- assessment of CU policies and procedures and training materials
- identifying areas for improvement and making key recommendations for implementation
- facilitating a workshop on lessons learned
- providing remote follow-up support to the CUs visited.

Coaches should be flexible and have a broad range of experience to draw on, be an excellent communicator and must be comfortable working in a challenging environment.

5. What is the time commitment needed?

The time commitment is approximately 15 days in total. This will include an in-person pre-departure training in the League’s office, approx. 10 days in-country, a debrief on return to Ireland and provision of remote support once a month for a min of 3 months.

6. What is the financial cost?

The successful coaches will be kindly requested to contribute €2,500 towards the total cost of their participation on the Volunteer Coaching Programme. This covers flights, insurance and in-country costs including accommodation, transport, meals. This fee can be covered by the credit union or participants can fundraise, or it can be a mix of both and fundraising support will provide, if needed.

Note: The fee has been increased from previous years in response to rising costs.

7. What support will be provided to coaches?

The Foundation, and the team in Freetown, will provide the following as part of the volunteer programme:

- Book flights, accommodation, travel insurance
- Provide necessary information in advance of travel, and organise logistics
- Support the coaches in planning the individual credit union visits and training, if required
- Arrange pre-departure training in Ireland, including cultural training
- Provide a staff member to accompany the coaches in Sierra Leone
- Provide on-going support throughout the duration of the programme
